

ENTER TO WIN CONTEST DETAILS

To be eligible to win the Draw, you must be a resident of Manitoba. The reward must be used/redeemed with any Massage Therapy Association of Manitoba practicing member in good standing.

1. The **\$500 in Massage Therapy Services** (referred to as the “Draw”) is a promotional giveaway administered by Massage Therapy Association of Manitoba.
2. The contest period is October 16, 2014 through to midnight (CT) October 28, 2014.
3. To be eligible to win the Draw, you must be a resident of Manitoba.
4. Entries are limited to one (1) per person/email address.
5. Only entrants over the age of 13 are eligible to win. Winners between the ages of 13 and 18 must defer their winning entry to a parent or guardian when they claim their prize.
6. There is no purchase necessary to enter and win.
7. To enter the contest, you must submit your details (name, email address, province, gender, year of birth and how you found out about the contest) through the online entry form.
8. A prize will be awarded for the Draw to one randomly selected winner. The sole determinant of the Draw winner is Massage Therapy Association of Manitoba’s server computer. Entrants cannot appeal.
9. The winning entrant will be contacted by email immediately upon selection. The selected winner must respond to that email within 72 hours of being contacted in order to claim the prize. If the prize is not claimed, another random winner will be chosen and given 72 hours to respond. This process will be repeated until a winner has been selected.
10. The prize certificate will be mailed within 14 days. The winner must provide us with their full mailing address when they reply to the winner’s email in order to receive their prize.
11. Employees and Members of the Massage Therapy Association of Manitoba are not eligible for Draw entry.
12. Prizes must be accepted as awarded, are not transferable, and cannot be substituted with any other prize or for the cash value of the prize.
13. The winner will be awarded gift cards to be used/redeemed with any Massage Therapy Association of Manitoba practicing member in good standing. The Massage Therapy Association will track the amounts and keep the winner notified. The winner may use their prize in more than one location, if preferred.
